Please note:

- The name and address on the valid, eligible concession card must match the details on the Horizon Power electricity account.
- Electricity must be supplied at the A2 residential tariff.
- Customers supplied at the K2 (combined residential and business) and L2 (business) prices are not eligible to claim rebates under the State Government Energy Rebate Scheme.
- Rebates are applied from the date the approved application is received.
- Rebates are not retrospective and cannot be backdated.
- In multiple residences where the electricity is supplied through one main Horizon Power meter, each additional residence with a subsidiary meter is also charged a supply charge. A rebate may be claimed by eligible concession card holders supplied through subsidiary meters.
