

Important information for Permanent Caravan Park Residents applying for the Energy Rebate

Please read below before filling out the Energy Rebate application form.

What is the Energy Subsidy?

In May 2004, the State Government introduced the Power Price Equity Scheme to give permanent caravan park and park home residents access to energy rebates. Horizon Power administers the energy rebates for permanent park residents in caravan parks and park homes that are supplied electricity by Horizon Power.

The Power Price Equity Scheme allows permanent caravan park home residents to apply for the Energy Rebate. If the applicant has dependant children listed on their card they will also be entitled to dependant child rebate, which is also calculated at a daily rate.

To be eligible for the Energy Rebate you need to:

Be a permanent caravan park resident for three months or more

AND

Be a holder of one of the following concession cards:

- Western Australian Seniors Card
- Pensioners Concession Card
- Department of Veterans' Affairs Pensioner Concession Card
- Centrelink Health Care Card
- Seniors Health Card
- Gold Card for TPI, EDA, War Widow, Dependent

Please note: To be eligible for the dependant child rebate you must have dependant children listed on your concession card. Applications received with dependant children listed on the card will automatically be granted the dependant child rebate - you do not need to fill in a new application form for this rebate.

My partner and I both have concession cards - how many applications will be accepted?

Only one application per rebate, per individual caravan park resident will be processed.

Information on how to apply for the Energy Rebate

Please complete an Energy Rebate application form. Applications are valid for a period of no more than 12 months and cannot be processed unless the application form is fully completed and copies of your valid, eligible concession cards are attached.

How much will I receive from the Energy Rebate?

The Energy Rebate is equal to the daily supply charge and if dependant children are listed on your card then you will automatically be eligible for the dependent child rebate which is calculated daily, based on the number of dependant children listed on the concession card. How is the dependant child rebate calculated?

The dependant child rebate is calculated on a daily basis within the payment period, according to the number of dependant children listed on the concession card.

Dependant child rebate Daily Rate (including GST)	
Number of children	Cents per day
1	40.99
2	51.74
3	62.49
4	73.24

How will I receive the payment?

Payments will be made twice yearly, direct to your nominated bank account via Electronic Funds Transfer (EFT). On the payment dates the EFT payment of the subsidies will be calculated on a daily basis from the effective date to the end of the payment period. All payments will be itemised on your next bank account statement.

How will I know if my application has been received?
